The Board governing the Tivoli Theatre will be divided into three areas of focus. The intent is to have a 9-member board, divided into 3 tiers of focus. These are the areas of focus you can serve on. Each will meet monthly with a second meeting of the whole board to discuss what each tier has planned. The tiers and theatre director shall meet together and can set their designated date & time.

Each committee will need a secretary.

The Tivoli board should elect members to serve the following offices:

- President
- Vice President
- Secretary

Treasurer - most duties could be deferred to the theatre director if deemed so by the board. Yet the treasurer should be able to sign or pay bills in the absence of the theatre director, should there be a vacancy.

Owen County Preservations Role

For the time being Owen County Preservations Inc. will remain the owner of the building. Owen County Preservations will also reserve the right to VETO any physical structure changes while it is the owner of the building.

Owen County Preservations will be willing to assist with fundraising, capital campaigns or grant writing. As the Tivoli will still be under the umbrella of Owen County Preservations 501C3.

Once the Tivoli Board has gotten a couple years' experience we will open the path on separating the 501C3 and building ownership.
